



### **Diverse & Growing Population**

Texas has added nearly **4.8**million new residents since 2010—more than California and New York combined.





### **Higher Education**

Texas has a robust network of higher education institutions that vary in size and program specializations but are all united by one commonality—producing top talent across the state. Texas universities and research institutions are **national and global leaders in R&D** in many industries, including electronics, medical, biotechnology, aerospace, advanced materials and energy.








# U.S. Ports of Entry in Texas

## Airports

#### **CONNECTION TO MAJOR MARKETS**

In Texas, more than 380 airports, including 26 commercial airports, make up the second-largest state airport system in the U.S.

Texas is home to six of the top 50 busiest airports in the country, by annual passengers boarded.

Texas has more airports than any other state, two international airline headquarters and a major hub for a third.



### Seaports

#### EASY ACCESS TO THE WORLD

Texas' seaports and Foreign Trade Zones (FTZs) are among those handling some of the nation's top amounts of cargo.

With 19 seaports, including 11 deep water ports with channels at least 30 feet deep, Texas ranks as the top U.S. state for manufacturing exports and shipment value.


Texas' seaports and Foreign Trade Zones (FTZs) are among those handling some of the nation's top amounts of cargo.

Texas is the #1 U.S. destination for foreign direct investment capital expenditures over the last two decades.




### International Trade & FDI

#### THE NATION'S TOP CORPORATE TAX ENVIRONMENT


With no corporate or personal income tax, Texas has one of the lowest tax burdens in the nation.

Governor Abbott and the Texas Legislature continue efforts to make the state even more competitive from a tax perspective:




- Franchise tax reduction: 25% reduction in the franchise tax
- Property tax reform: Reduction of property taxes and limit on the ability for local governments to increase property taxes
- No personal income tax: Constitutional ban on personal income tax









## ECONOMIC AND BUSINESS DEVELOPMENT UPDATE

#### TEXAS ECONOMIC DEVELOPMENT MODEL

Prospects come from a variety of sources: company direct, consultants, regional recruitment efforts, brokerage community, site selectors, utility company or the State.

PROSPECT IDENTIFICATION

#### **RFI CREATION**

Created by company or consultant (often with regional EDO or State assistance) Communities identify feasible project sites, leading/hosting site visits, creating incentive summary and initial response packages.

SITE SEARCH – LOCAL LEAD

#### **STATE SUPPORT**

The State provides advisory project support. Once the final Texas site is chosen, then state incentive applications are submitted.


Company makes final site decision. Local and state incentive agreements are signed. Project is announced.

LOCATED PROJECT

The State of Texas' economic development model provides decentralized and local control to Economic Development Organizations (EDO).







